Systems incorporating MIRALON® Pulp require very low loading percentages (<1% for electrical [system-dependent] and <10% for mechanical) when compared to conventional fillers, thus preserving more of the base material properties.

MIRALON® Pulp has been proven to enhance thermoplastic and thermoset resins, silicone elastomers, polymer fiber-reinforced composites, coatings, and adhesives.
